NOTIFICATION

SUBJECT: RELOCATION OF DIRECTOR GENERAL (CA&E), NORTH LAHORE TO ISLAMABAD

Consequent upon transferring of major audit entities from Director General (CA&E) North, Lahore, to DG Audit Power, and DG Audit Petroleum & Natural Resources, work load assessment was carried out to review the existing setup of DG (CA&E) North, Lahore. Work load assessment shared during series of meetings reflected substantial reduction in workload at Lahore for Federal Government Commercial Enterprises.

- 2. Keeping in view above, the Auditor General of Pakistan has been pleased to approve the relocation of Directorate General (CA&E) north; From Lahore to Islamabad with immediate effect.
- 3. Directorate General, (CA&E) North at Islamabad shall supervise Directorate of CA&E at Lahore, Directorate of CA&E at Wah and Director Hq at Islamabad. Number of entities to be dealt at three offices of CA&E North shall be as under

4. Transfer of Posts: In order to carry out smooth transition, Administration Wing to transfer the 26 Posts from Director General (CA&E) North, Lahore as well as Director, CA&E, Wah, as per following details and same may please be placed at the disposal of the relocated office of the Director General Audit (CA&E), at Islamabad. Separate notification in this regard shall be issued by Administration Wing of the AGP office.

- 5. Additional Budget: Additional budget requirement for rent of building, Furniture & Equipment, Shifting of Office record of the relocated office of the Director General (CA&E) North, Islamabad shall be notified by the Budget Wing, separately in consultation with relevant FAO.
- 6. Audit Matters: During Audit Year 2018-19 {Feb-Jun 2019}, Audit of entities related to CA&E North at Islamabad shall be completed by teams at Lahore as per approved audit plan. In the next year audit plan 2019-20, these entities {Islamabad Based} shall stand transferred to DG (CA&E) North at Islamabad. In order to reduce cost of travel on PAC meetings, it has been decided that efforts be taken by DG (CA&E) North at Lahore to shift PAC section immediately.
- 7. **Transfer of Record and Assets**: A Committee to be constituted comprising representatives of (CA&E) Islamabad and Lahore office not below the rank of BPS 18 immediately. A complete check list and SOP shall be notified by DG (CA&E) North for transfer of record between two locations. All the files and reports shall be indexed and proper handing / taking over exercise to be completed within one month.
- 8. Office Space- DG B&A, AAG (P) and Director CA&E North to jointly visit HQ office and AATI Islamabad Premises for suitable place to relocate office of DG (CA&E) North at Islamabad. The committee shall finalize its proposal within a week's time.
- 9. Grievance Redressal Committee: Any issues arising relating to transfers hall be addressed on priority. A Committee is constituted headed by Director (Establishment) AGP office and two members, Director CA&E North Audit, Director CA&E Lahore and Assistant Auditor General (Personnel) for placement and deciding any grievances for transfer of posts and persons if any. The Committee shall decide all such cases within 3 months from the date of notification.
- 10. Any case of duplication/discrepancy for audit jurisdiction shall be decided by AGP
- 11. All the concerned authorities are requested to make correspondence with the above relevant offices, accordingly.
