- Surety Bond
- Undertaking
- Copy of Covid-19 Full Vaccination Certificate
- For candidates using ordinary passport, No criminal record certificate attested by Ministry of Foreign Affairs of Pakistan will be needed.


3. Relevant Ministries / Divisions / Attached Departments and Provincial P & D Departments must note the following points while nominating the candidates:
