Subject: WGISTA PROJECT: CREATE A LIST OR DATABASE OF EXPERTS OR CONSULTANTS ON ADVANCED AND EMERGING TECHNOLOGIES

Working Group on Impact of Science & Technology on Auditing (WGISTA) has undertaken a project, to establish a database of experts and consultants who specialize in emerging and advanced technologies, called "Create a list or database of experts or consultants that can be shared and used by INTOSAI members and Regional Organizations". This project aims to address one of the challenges that Supreme Audit Institutions are faced with respect to emerging and advanced technologies - absence of a platform which could serve as an interface between SAIs and experts and knowledgeable resources from within SAIs.

WGISTA invited all SAIs to nominate their experts who possess a certain set of competencies related to advanced and emerging technologies while participation is entirely voluntary. According to the WGISTA terms of reference for this project, the database should include experts with competencies in the following advanced technologies.

Artificial intelligence

Blockchain technology iii. Robotic process automation

iv. Cybersecurity

Data analytics

vi. 5G wireless technology

vii. Machine learning

viii. Quantum computing
