Organizations) who have to attempt the following paper(s) of Level-1 & 2 are hereby informed that they must get registered as per their eligibility* for appearing in CBE Examinations during 20th January – 10th February, 2022.

- 1. The online Quarterly CB Exam Forms for Summer Examination 2022 will be available on Student login (coaching.pipfa.org.pk) at PIPFA Website, from 20th January, 2022.
- 2. The students intend to enroll in Quarterly Computer Based Examinations Summer-2022 may opt to Remote Access Examinations or Physical Lab Based Examinations as per their convenience.
- 3. CB Exam Forms are required to be filled in by the Examinee himself/herself with his/her own Login ID on Student login.
- Students must sign the printout of the Examination Forms and submit at any PIPFA office or approved Coaching centers along with the paid fee voucher by 10th February 2022; otherwise forms will not be processed.
- 5. Fee must be submitted through printed fee voucher at any Faysal Bank branch.
- 6. Pay Order, Demand Draft, Cheque and Online transfers are NOT acceptable.
- 7. Students are advised to pay Annual Subscription or Coaching fee (If Due) before submitting CB Examination Forms otherwise the fee will be added in CB exam fee voucher.
- 8. Papers once marked by the Examinee, in which he/she intends to appear, shall not be changed. Special care must be taken while selecting the papers in the online CB Exam Form.
- 9. Manually filled CB Examination Forms will be Rejected summarily.
- 10. Manual editing and overwriting on CB exam form will NOT be taken under consideration.
- 11. FILLING ONLINE EXAM FORM WILL NOT BE CONSIDERED SUBMITTED, until the print of filled exam form along with paid fee voucher from PIPFA website is submitted to PIPFA office, for further processing.

CBE Exam Form will not be accepted after due date i.e 10th February, 2022. The verification and stamp of PIPFA Centers / Approved Coaching Centers for coaching confirmation on CB Exam Form is a must (For first time appearance only).
