REGULARIZATION OF THE SERVICES OF THE EMPLOYEES WORKING ON CONTRACT BASIS UNDER ASSISTANCE PACKAGE FOR THE FAMILIES OF GOVERNMENT EMPLOYEES WHO DIE IN SERVICE.

The undersigned is directed to refer to this office circular No. 1577/Estt-C/40-2003-1VPF dated 23. December, 2016 on the subject cited above (copy enclosed). wherein this office convey the direction of competent authority that cases regarding regularization of the services of employees working on cotract basis under PM Assistance Package may be decided at your end being appointing authority, however, the above mentioned circular was later on withdrawn vide this office circular No. 579/Estt-C/40-2003-1V-PF dated 16th May, 2017 (copy enclosed).

Now, it has come to notice of competent authority that some offices regularized the services of employees working on contract basis under PM Assistance Package in light of this office circular dated 23rd December, 2016, despite the fact that the same letter was cancelled ab-initio vide letter dated 16th May, 2017. The competent authority has directed to furnish the detail of employees (if any) regularized vide this office circular dated 23rd December, 2016.
- 3. It is, therefore, requested that the said information (if any) may kindly be provided at the earliest, in order to proceed further in the matter.
