To develop and enhance the skills and knowledge of officers/officials, DAGP is providing the CIPFA UK certified diplomas in nine (09) thematic areas. This office is finalizing nominations for "State Owned Enterprises/Extractive Industries Audit".

- 2. For IDC officers, BS17 and above whereas for DC cadre, Audit Officers, Assistant Audit Officers and Senior Auditors are eligible to apply for the said course. The selected candidates will have to sign a bond with AGP office to work for 01 year under thematic audit regime. No withdrawal after nomination will be accepted.
- 3. The thematic audit training course is a hybrid program. This will comprise e-learning and two-weeks physical classes. Candidates will be allowed two re-sits for the examination within one year of

registration. The assessment will be carried out through Computer Based Exam, comprising of multiple-choice questions.

4. It is requested that maximum 05 nominations from each office for "State Owned Enterprises/Extractive Industries Audit" (in particular, those FAOs which have the mandate to conduct the subject audit) may be sent to this office **through proper channel** along with filled nomination forms (Annex) by 10<sup>th</sup> May, 2023 for onward submission to the quarter concerned. Nomination forms received in this wing mentioning preference of this training before this letter will only be considered if sent through proper channel.
