Subject: THE GOVERNMENT OF BRUNEI DARUSSALAM SCHOLARSHIP TO FOREIGN STUDENTS TENABLE IN BRUNEI DARUSSALAM 2023/2024 ACADEMIC SESSION.

The Ministry of Foreign Affairs of Brunei Darussalam has invited applications for the subject Scholarship.

2. The academic session commences in July/August 2023. Officers/officials not exceeding the age of 35 years (on the first day of July on the year when programme commences) and proficient in English with a Credit o6 at GCE 'O' Level Examination or a Grade "C" in IGCSE English (as a second language) or an IELTS score of 6.0 or a TOEFL minimum score of 550 are eligible to apply.



All the officers/officials who intend to apply for Post Graduate/Masters Degree Programme may forward their applications (on attached Form 1) to HRM Wing at least 15 working days before the **closing date of 15.02.2023, duly endorsed by their controlling officers/offices**, for grant of No Objection Certificate (NOC) to apply. There will be no financial liability whatsoever on the part of DAGP/GoP.

4. Before applying for subject scholarship, the aspiring officers/officials may also carefully read the Eligibility Criteria for Foreign Long Term Scholarship/Fellowship/Self-Financed Study Programmes circulated vide this office letter No. Misc/DG-HRM/2020/137, dated 29.11.2021 as amended from time to time.
