

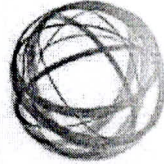

ICGFM encourages senior PFM professionals, government ministry leaders, early career professionals, and donor and government funders from diverse organizations to submit a proposal.

Conference presentations due from selected presenters:	July 24, 2023.

HOW TO SUBMIT: Please complete the online submission form to ensure your proposal is expeditiously reviewed.

NOTE: If you are submitting a panel presentation, you must include the Name, Title, Organization and Contact Information for no more than three (3) potential panelists, including yourself

METHOD OF SELECTION: All submissions will be reviewed by the Program Committee.

Criteria on which proposals are evaluated include: Interest and relevance of the topic to the public financial management audience; potential to advance the knowledge and understanding of those in the field; experience speaking at ICGFM or other professional conferences. **ICGFM membership is strongly encouraged.**

CONFERENCE DESCRIPTION: The ICGFM Conference is an annual gathering of public financial management practitioners, experts and thought leaders who come together to discuss best practices, financial reforms, and other methods available to better serve their citizens. Representatives from Africa, Asia, Europe, the Middle East, Latin America, the Caribbean, and North America share their practical experiences meeting common challenges and employing innovative approaches in all areas of the PFM cycle.
