Subject: Request for Nomination in IS/IT Audit under CIPFA Training Plan.

To develop and enhance the skills and knowledge of officers/officials, DAGP is providing the CIPFA, UK certified training in nine (09) thematic areas. Under this initiative, UK based Diplomas in nine (09) thematic areas are being offered. We are finalizing nominations for IS/IT audit and for this maximum five (05) nominations from each FAO (25% IDC, 75% DC) are needed.

- 2. Following is the selection criteria and selection process for the subject course:
 - a) IDC- BS17 and above may apply.
 DC- Senior Auditors, Asst. Audit Officers and Audit Officers are eligible.
 - b) The auditors who would be selected under thematic course will have to take an online exam and successful ones will be awarded CIPFA level 4 Diploma in Forensic Audit.

- c) No withdrawal after nomination will be accepted.
- d) The training will start tentatively in month of February 2023 at PAAA Campuses of Islamabad, Lahore and Karachi.
- e) As per the offer, the official / officers will be offered thematic audit course with the condition to sign a bond with AGP office to work for 01 year under thematic audit regime.

Delivery mode of thematic audit training: -

3. The thematic audit training course is a hybrid program. This will comprise e-learning and two-weeks physical classes. Candidates will be allowed two re-sits for the examination within one year of registration.

Assessment:

- 4. The assessment will be carried out through Computer Based Exam, comprising of multiple-choice questions. The level 4 modules in CIPFA professional qualification are all assessed via multiple choice questions, and it is commonly used by other professional bodies for their level 4 qualifications.
- 5. It is requested that 05 nominations for IS/IT Audit training course may be sent to this office along with filled nomination forms (Annex) by 20th December for onward submission to the quarter concerned.
