Terms of auction:

1. The bidders must bring their original CNIC and provide complete address/ telephone numbers and attested copy of CNIC on the day of Auction.
2. Successful bidder must deposit earnest money i.e 10% of his accepted bid in cash on spot and remaining amount must be deposited within five days of auction. In case of default, earnest money shall be forfeited.
3. A bidder wishing to participate in the bidding process shall deposit a refundable bid security of Rs.30,000/- (Rupees Thirty Thousand Only) in shape of demand draft in the name of DDO of this office. Only such bidders will be allowed to participate in the auction. In case of default or backing out after acceptance of his bid this demand draft shall stand forfeited.
4. The transfer of ownership documents would be the responsibility of the successful bidder.
5. Documents of the vehicle(s) will be delivered after complete payment.
6. Withholding tax on the bid amount shall be charged as per prevailing rules.
7. It is the responsibility of the bidders to check the chassis \ engine number, documents etc, before auction, this office will not be responsible for any complaint later on.
8. Possession of vehicle will be given to the successful bidder, after transfer of vehicle in his name from the ETO concerned.
9. Other details will be announced at the time of auction.
10. The auction committee/ competent authority reserve the right to accept or reject any or all bids in accordance with Rules 33 of the PPRA Rules 2004.
