

OFFICE MEMORANDUM

SUBJECT: ONE PLOT ONE EMPLOYEE POLICY-2023.

The undersigned is directed to refer to the subject noted above and to say that a decision approved by Federal Cabinet in its meeting held on 22nd February, 2023 that:-

"Public/ government servants shall not be allotted more than one plot with immediate effect"

2. In the light of above decision, henceforth, the plot allotment policy to the Public/ Government servants shall be as under:-

- a. Only one plot will be allotted to government employees and other specified groups during the entire service under allotment of plot schemes announced by the Federal Government Housing Authority (FGEHA) from time-to-time.
- b. The one plot allotment will be made as per the approved policy of authority by the executive committee/board from time-to-time as per their entitlement according to their scales from BS-01 to BS-22.

3. All Ministries/Divisions are requested to ensure circulation of the above mentioned decision/policy to their attached departments/organizations under their administrative control for information and compliance.
