Status of On-Going Training Courses due to Coronavirus Situation

Kindly refer to the subject cited above.

- 2. All the courses of NSPP i.e. 112<sup>th</sup> National Management Course (NMC), 27<sup>th</sup> Senior Management Course (SMC) and 29<sup>th</sup> Mid Career Management Course (MCMC) have been redesigned keeping in view the prevailing health emergency on account of COVID-19. Remaining training activities will be completed through remote tele-teaching mode by using Zoom/Skype and E-portal of respective courses. These essentially comprise of Simulation Exercises, Case Studies, Analysis Papers, Topical Discussions and Research Paper particularly related to the Foreign Study Tour of the respective country assigned to different participants of NMC.
- 3. Courses have been rescheduled by reducing the duration of 3 weeks of NMC, 5 weeks of SMC and 3 weeks of MCMC respectively, subject to the slight modifications by the respective NIMs made keeping in view the activities completed before the suspension of the courses, as under:-

a. 112<sup>th</sup> NMC

1st June to 6th August, 2020

b. 27th SMC

1st June to 24th July, 2020

(Lahore, Karachi, Peshawar & Islamabad)

c. 29th MCMC

1st June to 3rd July, 2020

(Lahore, Peshawar & Quetta)

However, 29th MCMC at NIM Karachi will conclude on 10th July, 2020

It is, therefore, requested that all the participants may be directed to join the 112<sup>th</sup> NMC, 27<sup>th</sup> SMC and 29<sup>th</sup> MCMC, respectively w.e.f. 1<sup>st</sup> June, 2020 through E-portal of the respective unit.
