
**WAIVING OFF OUTSTANDING BALANCES OF GOVERNMENT
ADVANCES IN RESPECT OF GOVERNMENT EMPLOYEE WHO DIED
IN SERVICE**

The undersigned is directed to refer to the subject cited above and to state that it has been observed that various Field Audit Offices are forwarding the case for waiving off outstanding balances of House Building Advances for government employees who died while in services under Prime Minister Assistance Package, without providing the relevant documents/information for processing of the case.

2. It is, therefore, requested that the following information/documents may be kindly be provided with each subject cases henceforth:

- a) CNIC of deceased employees and widow concerned
- b) Death Certificate issued by NADRA/concerning Union Council
- c) Last Salary Slip showing outstanding balance of Housing Building Advance
- d) Request of widow for waiving off outstanding balance of Housing Building Advance
- e) Letter of sanctioning House Building Advance to the deceased employee
