Section 6.13: Bank Guarantee and Performance Security

- Within seven (07) working days of signing of contract, the vendor shall furnish to the Purchaser a bank guarantee @ 10 % of the contract value. Upon verification of the bank guarantee, mobilization advance shall be issued to the vendor.
- There shall also be a performance guarantee @ 10 % of the contract value to be furnished by the vendor to the purchaser within seven (07) working days of the signing of contract.
- The proceeds of the performance security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.
- The performance security shall be denominated in the currency of the Contract acceptable to the Purchaser and shall be a Bank Guarantee issued by a scheduled bank located in Pakistan, in the form provided in the bidding documents or another form acceptable to the Purchaser
- The performance security will be discharged by the Purchaser and returned to the Supplier not later than thirty (30) days following the date of completion of the Supplier's performance obligations under the Contract, including any warranty obligations.
