NOTIFICATION

No. 1370 -Dir(A)/11-351/Discip/2017 WHEREAS, disciplinary proceedings under Government Servants (Efficiency & Discipline) Rules, 1973 were initiated against **Mrs. Anbreen Azmat Chohan, (BS-17 / PA&AS Officer)** vide Charge Sheet No.694-Dir(A)/11-351/Discip/2017, dated 12.07.2017 and Mr. Adnan Rafique, Director General (HRM), Auditor General's Office, Islamabad was appointed as Inquiry Officer to conduct inquiry against the accused officer on account of allegations constituting "Inefficiency" and "Misconduct" in terms of Rule 3 (a) and (b) *ibid*.

2. WHEREAS, the charge sheet dated 12.07.2017 alongwith statement of allegations was dispatched on her known address as well as on her email address on 12.09.2017 besides publishing in the leading newspapers on 15.09.2017 with the direction to collect the Charge sheet/Statement of allegations from the nominated inquiry officer and submit written defence reply within seven (07) days but the accused officer neither contacted nor submitted the reply to the inquiry officer. Inquiry Officer served upon her notice on 27.09.2017 with the direction to submit her defence reply but, the accused did not participate in the inquiry proceeding. The inquiry officer deputed two officers to visit the accused on her available address on 16.11.2017 but failed to locate the whereabouts of the accused officer. The Inquiry Officer also contacted NADRA for provision of address. The Inquiry officer again posted letter on 27.12.2017 on the two new addresses provided by NADRA, the same were returned undelivered. The Inquiry Officer submitted report with conclusion that officer has been found guilty of "Inefficiency" and "Misconduct" and since the charge of un-authorized absence levelled against her was established, the Inquiry Officer finalized the proceedings *ex-parte*. Thereafter, a Show Cause Notice dated 21.02.2018 was issued to the accused officer besides publishing in the leading newspapers on 27.03.2018 affording her fourteen days to respond to the same wherein officer was also called upon to appear for personal hearing before the Authorized Officer. She again failed to obey the direction.

3. Before deciding this case, the Auditor-General of Pakistan/ Authority afforded her opportunity of personal hearing on 25.06.2018 which she did not avail. After considering the charges framed in the Charge Sheet and other available record, the accused officer has been found guilty of "Inefficiency" and "Misconduct" under Rule 2 (4) read with Rule 3 (a) and (b) of the Government Servants (Efficiency and Discipline) Rules, 1973. The Auditor-General of Pakistan being Authority, under Rules 5(1). (iv) of E&D Rules 1973, in this case after having considered all aspects and material relating to the case and recommendations of the Authorized Officer has therefore, imposed the major penalty of "**Removal from Service**" upon **Mrs. Anbreen Azmat Chohan, (BS-17 / PA&AS Officer)** under Rule 4 (1) (b) (iii) of the Government Servants (Efficiency & Discipline) Rules, 1973 with effect from 18.03.2017.


