NOTIFICATION

No. 761 /Dir(A)/11-290/Discip WHEREAS, disciplinary proceedings under the Government Servants (Efficiency & Discipline) Rules, 1973 were initiated on complaint of Employees Old Age Benefits, Karachi against **Mr. Zafar Iqbal Gondai, Ex-Chairman EOBI, Karachi (a BS-20 / PA&AS Officer)** vide Auditor General's Summary No. 593/Dir(A)/11-290/Discip dated 11.05.2016 and Mr. Tariq Bajwa, the then Chairman FBR/Secretary Revenue Division, Islamabad was appointed as Authorised Officer by the Prime Minister of Pakistan being Authority and inquiry proceedings were conducted by Mr. Haroon Muhammad Khan Tareen, a BS-21 Officer, Inland Revenue Service, against the accused officer on account of allegations leveled against him in aforementioned Summary which constitutes "**Inefficiency**", "**Misconduct**" and "**Corruption**" in terms of Rule 3 (a), (b) and (c) ibid.

2. **WHEREAS**, on careful consideration of the charges and statement of allegations against the accused officer Mr. Zafar Iqbal Gondal, the findings of the Inquiry Officer in his report dated 15.08.2016, the recommendations of the Authorised Officer dated 04.01.2017, the contents of the personal hearing note dated 19.06.2017 recorded by the officer designated to give a personal hearing to Mr. Zafar Iqbal Gondal on behalf of the Prime Minister as well as the written statement submitted by Mr. Zafar Iqbal Gondal to the hearing officer on the day of hearing and the evidence available on record, the Prime Minister has been pleased to observe that allegations leveled against accused are found established.

3. In the light of above facts, the Prime Minister, in his capacity as "Authority", within the meaning of the Government Servants (E&D) Rules, 1973 in the case of Mr. Zafar Iqbal Gondal, a BS-20/PA&AS Officer, has been pleased

to conclude that Mr. Zafar Iqbal Gondal is guilty, beyond reasonable doubt, of "corruption", "misconduct" and "inefficiency" as charged, within the meaning of the rules ibid and to, therefore, impose upon him the major penalty of "dismissal from service under Rule 4(b)(iv) of the Rules ibid as recommended by the Authorised Officer.
