NOTIFICATION

No. 696 /Dir(A)/11-301/Discip/2014 WHEREAS, disciplinary proceedings under the Government Servants (Efficiency & Discipline) Rules, 1973 were initiated against Mr. Sajid Ali Khan, (BS-19 / PA&AS Officer) vide Charge Sheet No. 374/Dir(A)/11-301/Discip/2014 dated 29.12.2016 and Mr. Farrukh Ahmad Hamidi, Accountant General Sindh, Karachi was appointed as Inquiry Officer to conduct inquiry against the accused officer on account of allegations levelled against him in aforementioned charge sheet which constitutes "Inefficiency", "Misconduct" and "Corruption" in terms of Rule 3 (a), (b) and (c) ibid.

2. WHEREAS, the Inquiry Officer submitted inquiry report with conclusion that the officer has been found guilty of "Inefficiency", "Misconduct" and "Corruption" Thereafter, a Show Cause Notice of even number dated 16.05.2017 was issued to the accused officer to which officer replied accordingly and the Authorized Officer also afforded him an opportunity of personal hearing which was held on 08.06.2017 as requested by accused officer.

3. After considering the charges framed in the charge sheet and other available record, the accused officer has been found guilty of "Inefficiency", "Misconduct" and "Corruption" under Rule 2 (4) to be read with Rule 3 (a), (b) and (c) of the Government Servants (Efficiency and Discipline) Rules, 1973. The Auditor-General of Pakistan being Authority in this case, after having considered all aspects and material relating to the case and recommendations of the Authorized Officer has therefore, imposed the major penalty of "Compulsory Retirement" upon Mr. Sajid Ali Khan, (BS-19 / PA&AS Officer) under Rule 4 (1) (b) (ii) of the Government Servants (Efficiency & Discipline) Rules, 1973 with immediate effect.


