NOTIFICATION

No. 1435-Dir(A)/11-299/Discip: Disciplinary proceedings under the Government Servants (Efficiency & Discipline) Rules, 1973 were initiated against Mr. Sharifullah, BS-18/PA&AS, on account of "Inefficiency" and "Misconduct" vide Charge Sheet No.354-Dir(A)/11-299/Discip/2015, dated 20.12.2016. Mr. Akbar Ali Khan, Controller Military Accounts (PC), Peshawar was appointed as the Inquiry Officer to conduct inquiry into the charges leveled against the officer. According to Inquiry Report charge No.1 and 2 were proved, whereas charge No.3 and 4 remained undecided being subjudice matter. A Show Cause Notice No.836-Dir(A)/11-299/Discip/2015, dated 05.10.2017 was served upon the accused officer and he was also afforded opportunity of personal hearing by the Authorised Officer on 19.12.2017 which he availed:

2. The Deputy Auditor-General (A&C) being Authorized Officer under Rule 5(1) (iv) of E&D Rules 1973, in this case after granting personal hearing to the accused officer to afford him an opportunity to defend himself and having gone through the inquiry report and available documentary evidence has imposed the minor penalty of "Withholding promotion for two years" upon **Mr. Sharifullah, (BS-18 / PA&AS Officer)** under Rule 4 (1) (a) (ii) of the Government Servants (Efficiency & Discipline) Rules, 1973 with immediate effect.


3. **Mr. Sharifullah**, shall have a right to appeal to the Appellate Authority as provided under the Civil Servants (Appeals) Rules, 1977.
