

SUBJECT: 2018 MULTILATERAL AND SCHOLARSHIP TRAINING PROGRAMME PLAN FOR PAKISTAN IN CHINA

The undersigned is directed to state that Government of People's Republic of China has offered various Multilateral Training Courses / Seminars and Master Degree Programs in different disciplines for the year 2018 for Government of Pakistan officials (Lists attached). The requisite qualification and general requirements are as under:-

d. Eligibility Criteria

- Officers (BS-17 & above / Permanent only) of Ministries / Divisions / Attached Departments and Provincial Governments most relevant to the training programmes.
- Maximum age limit is 50 years for BS 20 & above, and 45 years for BS 17-19.
- Be in good health and free from any infectious disease with health certificate.
- Proficiency in English.
- Passport having minimum validity of six months.
- Contract Employees are not eligible

e. Expenses

The following expenses are to be borne by the Chinese Government.

- Round-trip air tickets
- Transit allowance
- Boarding and Lodging
- Daily Allowance of
- 60-80 RMB

f. Documents Required

The following documents (02 sets of each) are required to be sent alongwith the nomination:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Two copies of valid passport.
- Copy of CNIC.
