
After due date no registration will be accepted. The students are advised to show their PIPFA Registration Card (in original) at the time of registration at the Computer Institute and also attach an attested copy along with the Registration Form. The verification and stamp of coaching centers / approved colleges on CBE Registration Form is a must (For first time appearance only).

Students are also informed that instead of cash payment in the head of CBE Fee at PIPFA approved CBE Centers; the students are required to pay through demand draft or pay order only in favor of PIPFA.

The CBE (Level-1) are likely to be held from 19th February, 2018 and onward. The schedule of CBE will be communicated in due course of time. The students are advised to be in contact with PIPFA Head/ Office, Contact Offices or visit www.pipfa.org.pk for confirmed schedule of CBE Quarterly Summer - 2018.

As per PIPFA Career Plan, the number of examinees required to conduct a CBE at any center is at least 10. In case of less numbers of examinees, students will be transferred to any other CBE center of their own choice.

Quarterly CBE will be conducted under new syllabus 2015 for the papers of Quantitative Method, Basic Accounting, and Business English & Behavioral Studies.
