- Be a middle class official from central bank, financial supervisory agency and/or Ministry of Finance.
- Have more than 5 years experience in the field of financial supervision and banks supervision
- Be a graduate of university preferably Master degree in the relevant field
- Be between the ages of 27-42 years (recommendable)
- Have a competent command over English both in written and spoken.
- Not be serving any form of military service.
