No. 399 –Dir(A)/11-175/Discip. Having been found guilty of “**Misconduct**” and “**Corruption**” as contained in Show Cause Notice No. 390-Dir(A)/11-175/Discip dated 12.04.2007, the Auditor-General of Pakistan being the Competent Authority, as defined in Section 2 (aa) of Removal from Service (Special Powers) Ordinance, 2000 read with SRO No. 563(I)/2000 dated 15.08.2008 and Section (2) of Act No. III of 2010, in exercise of powers conferred under Section 3 (e) of the said Ordinance has been pleased, after duly considering the recommendations of inquiry committee and reply to the Show Cause Notice and an opportunity of personal hearing afforded to him on 22.12.2016 but not availed, to impose major penalty of “**Dismissal from Service**” with immediate effect upon **Mr. Zahhid Rashid**, a BS-19/PA&AS officer (under suspension) (the then Chief Accounts Officer, Sales Tax, Lahore).


