SHOW CAUSE NOTICE

WHEREAS, a Charge Sheet along with Statement of Allegation bearing No.694-Dir(A)/11-351/Discip/2017 dated 12.07.2017 was issued against you **Mrs. Anbreen Azmat Chohan, BS-17/PA&AS** on account of willful absence from duty w.e.f. 18.03.2017.

2. **WHEREAS**, Mr. Adnan Rafique, Director General (HRM), O/o the AGP, Islamabad was nominated as Inquiry Officer submitted his Inquiry Report dated 24.01.2018 and has concluded that the charge leveled against you is **proven (a copy of the Inquiry Report is annexed)**.

3. **WHEREAS**, the undersigned, being the Authorized Officer, in terms of Rule 2 (3) of the Government Servants (Efficiency & Discipline) Rules, 1973 upon considering the Inquiry Report is of the view that the ibid charge against you stands established.


4. **WHEREAS**, upon non receipt of your response to the Charge Sheet/Statement of Allegations within allowed time period, a Notice of even number dated 12.09.2017 was also published in the leading newspapers to which reply has also not been received.

5. **AND WHEREAS**, the undersigned has come to the provisional conclusion that you appear to be guilty of **"Inefficiency" and "Misconduct"** within the meaning of the Rule 3 (a) and (b) under the Government Servants (Efficiency & Discipline) Rules, 1973 on account of the said acts of omission and commission on your part and you are liable to disciplinary action, which may involve the imposition of one or more penalties, including the major penalty of **"Dismissal from Service"** as prescribed in Rule 4 (b) (iv) of the said Rules.

6. **NOW THEREFORE**, you **Mrs. Anbreen Azmat Chohan, BS-17/PA&AS**, are hereby called upon to Show Cause in writing within **fourteen (14) days** of the receipt of this notice as to why major penalty of "**Dismissal from Service**" as prescribed in Rule 4 (b) (iv) of Government Servants (Efficiency & Discipline) Rules, 1973 may not be imposed upon you.

7. In case no reply is received within the specified period, it would be presumed that you have no defence to offer and action against you would be taken **ex-parte**. In your reply you should also state whether you desire to be heard in person by the undersigned (Authorized Officer).
