

No: 3/2018 SCJ dated: July 06, 2018 regarding the cited subject and to convey that the Establishment Division has revised the performa for provision of information regarding cited subject therefore the Auditor General of Pakistan has directed to call the requisite information afresh from BS-19 and BS-22 officers of Pakistan Audit & Accounts Service (IDC) on the following prescribed format by **July 15, 2018** failing which disciplinary proceedings will be initiated under E&D rules in case of ignorance of the directives of the competent authority. It may be noted that the requisite information pertaining to PA&AS (IDC) officers (**BS-19 & BS-22**) as per revised table appended below may please be forwarded to this office.
