
Subject: **DECLARATION OF ASSETS HELD AND ACQUIRED BY GOVERNMENT SERVANTS FOR THE YEAR ENDING ON 30TH JUNE, 2017**

The undersigned is directed to refer to the Establishment Division O.M.No.2/1/2013-D-4 dated 05.07.2017 on the subject noted above and to state that under Rule 12 of the Government Servants (Conduct) Rules, 1964 and administrative instructions issued by the Establishment Division from time to time on the above subject, the Declaration of Income, Assets and Liabilities for the Financial Year 2016-2017 alongwith other outstanding DoAs, if any, may be forwarded to this office on prescribed Proforma by **August 15, 2017**. The prescribed proforma is available on the website "<http://www.establishment.gov.pk>".

2. It may also be brought to the notice of the officers concerned that non-compliance of the above instructions is tantamount to 'Misconduct' in terms of the Government Servants (Conduct) Rules, 1964 and cognizable under the Government Servants

(Efficiency and Discipline) Rules, 1973. The declarations of assets of the officers are also required to be placed before the Promotion Boards in compliance of judgment of the Honourable Supreme Court of Pakistan.

3. In view of the above, it is requested to furnish declaration of Income, Assets & Liabilities belonging to PA&AS and also direct all PA&AS officers working under your administrative control to furnish their awaited Declaration of Income, Assets and Liabilities, immediately **otherwise necessary action under Government Servants (E&D) Rules, 1973 will be taken against defaulters.**
