The inter-se-seniority of 38th CTP is to be determined on the basis of:-

- i. Marks obtained in the competitive examination of the FPSC or notional marks (in case of inductees).
- ii. Marks obtained in the initial training programme or notional marks (in case of those inductees who commence their training with the specialized training programme)
- iii. Marks obtained in the Specialized Training Programme
- iv. Marks of the first attempt of FPOE minus marks obtained in failed subjects will be considered for the purpose of determination of inter-se-seniority

v. In the light of Establishment Division's OM Dated: 21.04.2014, a probationer failing to qualify FPOE in first attempt will only have increments withheld while his seniority will not be affected so long as he/she passes in second attempt. After failure in Second Attempt the seniority will be relegated to those who qualify their FPOE in first or second attempt and after failure in Third Attempt the seniority will be relegated to those who qualify their FPOE in second attempt so on and so forth. To determine the inter-se-seniority aggregate marks (as mentioned in sr. i to iv above) will be used to calculate the probationer's placement in the seniority list.

vi. In the light of Establishment Division's OM Dated: 05.03.2015 and 23.09.2015, the inter-se-seniority of the probationers, who were allowed deferment from CTP, henceforth was fixed at the bottom of the batch with which the probationers undergoes CTP but in the light of Clarification issued vide Establishment Division O.M. No: 1/3/2014-T-V dated: 26.12.2016, the inter-se-seniority of PA&AS officers who were allowed Deferment from CTP and their inter-se-seniority was earlier relegated has been re-determined with their original batch.
