

**Subject: STREAMLINING OF GOVERNMENT ADVERTISEMENTS**

In order to streamline the process of release of Government advertisements, the Prime Minister has been pleased to desire the following:

- i. The advertisements of the Federal Ministries / Departments / Organizations as well as Autonomous and Semi-Autonomous Bodies under their control will be released only through Press Information Department of Ministry of Information and Broadcasting. This will include all Government advertisements including classified and display advertisements; and,
- ii. The sponsoring organization will clearly indicate the availability of funds to Press Information Department with every requisition. The sponsoring organization will only specify the language, region, the periodicity of the publication and the number of insertion desired.

2. All Ministries / Divisions shall take necessary action on the directions of the Prime Minister and also to direct the organizations under their administrative control including corporations, autonomous bodies, semi-autonomous bodies etc. to strictly abide by these guidelines.


