The undersigned is directed to state that Government of People's Republic of China has offered thirty-seven (38) Master Degree Programs, one Doctoral Program (**List attached**). Chinese side further informed that candidates cannot be withdrawn once nominated and the final application result will be subject to the MOFCOM and University. The Programs will not involve any expenditure (TA/DA) on the part of Government of Pakistan. The requisite general requirements are as under:

General Eligibility Criteria

- Officers (**BS-17 & above**) of Ministries / Divisions and Provincial Governments most relevant to the training programmes.
- Proficiency in English.
- **Contract Employees are not eligible**

- iii. Female applicants should be more than 30%


Documents Required

- Full sets of application documents (**Annex-I**)
- FTC Proforma.
- Copy of CNIC.
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking

2. Nominations of suitable candidates fulfilling the eligibility criteria duly approved by the competent authority may be forwarded to this Division by **06th May, 2024 positively**. All Ministries / Divisions and Provincial P&D Departments must note the following points while nominating the candidates:

- a. Most relevant candidates should be nominated for Scholarship programmes.
- b. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the MoEAs' deadline will not be entertained.
- c. Nomination papers complete in all respect may be forwarded to EAD through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.

Full set of application documents at least including as below FYI:

- (1) A formal **degree certificate** of the degree with attestation by Higher Education Commission Pakistan (original or notarized photocopy);
- (2) **Academic transcript** of university with attestation by Higher Education Commission Pakistan (original or notarized photocopy);
- (3) **Resume** in English, including personal background, study experience after high school and working experience;
- (4) **Personal statement** in English; such as the motivation for applying, the advantages and accomplishment after fulfilling the program, the study plan and the career goal, etc.
- (5) **Two Letters of Recommendation**, original in English or in Chinese: one letter must come from a professor (or at least an associate professor) of the previously enrolled university; the other must come from the current employer or supervisor;
- (6) Personal and ordinary **passport**;
- (7) Photocopies of **English language Certificate**;
- (8) **Foreigner Physical Examination Form**;
- (9) CSC Application Form;
- (10) **NO Criminal Record certificate** from Birth with attestation by Ministry of Foreign Affairs ;
- (11) **Application Letter to ECCO** mentioned if the program applied full, accept similar programs or not.
