**OFFICE MEMORANDUM**

**SUBJECT: 2024 MULTILATERAL TRAINING PROGRAMS UNDER CHINA AID**

The undersigned is directed to state that Government of People's Republic of China has offered various Multilateral Training Courses / Seminars in different disciplines for the month of May to June, 2024 for officers of Government of Pakistan (**List attached**). Chinese side further informed that candidates cannot be withdrawn once nominated and the final application result will be subject to the MOFCOM. The Government of Pakistan will not be liable to bear any cost. The requisite general requirements are as under:

**1. Eligibility Criteria**

- Officers (**BS-17 & above**) of Ministries / Divisions and Provincial Governments most relevant to the training programmes.
- Proficiency in English.
- **Maximum age limit is 50 years for BS 20 & above, and 45 years for BS 17-19.**
- **Contract Employees are not eligible**

**2. Documents Required**

The following documents (**02 sets of each**) are required to be sent alongwith the nomination:


- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Copy of CNIC
- Copy of Passport at least six months of remaining validity and blank visa pages
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking
- No criminal record certificate or Police Clearance Certificate attested by Ministry of Foreign Affairs of Pakistan, if not visited China within 5 years.



3. Relevant Ministries / Divisions and Provincial P & D Departments must note the following points while nominating the candidates:

- a. Most relevant candidates should be nominated for the subject training programmes.
- b. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the EADs' deadline will not be entertained.
- c. Nomination papers complete in all respect may be forwarded to MoEA through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.

4. In order to avail trainings programs, it may be ensured that suitable nominations along with their complete documents provided to this Ministry before closing date.
