Upon selection, the IDC officers are required to approach Director Admn, AGP Office, Islamabad and DC officers/officials are required to approach Director Establishment, AGP Office, Islamabad, alongwith proof of selection, for NOC to proceeding abroad, regularization of study period and completion of other formalities, under intimation to HR Wing.

4. The officers/officials against whom disciplinary proceedings are pending or in process or the period of penalty imposed has not been elapsed, are not eligible to apply. The Director Admn, and Director Establishment may also ensure the same in consultation with Director Legal.
