No. F. 9(18)/2025-Legis.—The following Act of *Majlis-e-Shoora* (Parliament) received the assent of the President on the 27th June, 2025 and is hereby published for general information:—

*further to amend the Civil Servants Act, 1973*

WHEREAS it is expedient further to amend the Civil Servants Act, 1973 (LXXI of 1973), for the purposes and in the manner hereinafter appearing;

It is hereby enacted as follows:—

1. **Short title and commencement.**—(1) This Act shall be called the Civil Servants (Amendment) Act, 2025.

(2) It shall come into force at once.

2. **Insertion of new section 15-A, Act No LXXI of 1973.**— In the Civil Servants Act, 1973(LXXI of 1973), after section 15, the following new section 15-A shall be inserted, namely:—

“15-A. **Declaration of Assets.**—Notwithstanding anything contained in clause (g) of section 7 of the Right of Access to Information Act, 2017 (XXXIV of 2017), the declaration of assets of a Civil Servant of BS-17 and above, his spouse and dependent children, including domestic and foreign assets and liabilities, as may be prescribed, shall be digitally filed with the Federal Board of Revenue and same shall be publicly available, through Federal Board of Revenue, in accordance with the rules as may be prescribed:

Provided that the extent of disclosure, under this section, shall give due regard to the balance between public interest for good governance and individual's privacy and security.”
