

The employment statistics plays a vital role in effective policy formulation, by providing the policy-makers with useful insight regarding current employment trends. As per Rules of Business, Pakistan Public Administration Research Centre (PPARC), Establishment Division, is responsible for collecting, compiling, and maintaining statistical data in respect of Employees of Federal Government as well as of Autonomous/ Semi-Autonomous Bodies / Corporations under the administrative control of the Federal Government. It is worth mentioning that the collected information is compiled in the form of bulletins published on annual basis, which is used by Government functionaries, public policy decision-makers, researchers and the public at large.

2. With a reference date of July 1st, 2025, PPARC has to compile data for the Annual Statistical Bulletins for the year 2025-2026. To facilitate this data collection exercise, four proforma have been designed containing all the aspects of the employment in the Main Ministries/ Division, Constitutional Bodies, Attached Departments, Subordinate Offices as well as the employees of Autonomous and Semi-Autonomous Bodies and Corporations working under the administrative control of the Federal Government. These proforma are being sent herewith to be forwarded to all offices and organizations under the administrative control of your Division to obtain the said information/data in best public interest.

3. It is therefore requested that the concerned quarters may be directed to furnish the requisite information as on July 01, 2025, on the relevant four proforma, to Director General (PPARC), Ground Floor, Local Government & Rural Development Complex, G-5/2, Islamabad, enabling PPARC for timely completion of this assignment by the end of August, 2025.
