CIRCULAR

Subject: **CIVIL SERVANTS (AMENDMENT) ACT, 2025**


The undersigned is directed to refer Establishment Division's O.M. dated 03.07.2025 on the above subject, relating to amendment in the Civil Servants Act, 1973 (LXXI of 1973). The Act shall be called the Civil Servants (Amendment) Act 2025, and, after Section 15, a new Section 15-A shall be inserted, namely "**Declaration of Assets.**", whereby the declaration of assets of a Civil Servant of BS-17 and above, his spouse and dependent children, including domestic and foreign assets and liabilities, as may be prescribed, shall be digitally filed with the Federal Board of Revenues and same shall be publicly available, through Federal Board of Revenue, in accordance with the rules as may be prescribed:

Provided that the extent of disclosure, under this section, shall give due regard to the balance between public interest for good governance and individual's privacy and security".

2. This amendment in the Civil Servants Act, 1973, is also available on the website "<http://www.establishment.gov.pk>".

In view of the above, it is requested that all officers of Pakistan Audit and Accounts Service (PA&AS) working under your administrative control may be directed to ensure digital filing with the Federal Board of Revenue of their "Declaration of Assets", in compliance with the above referred instructions of the Government.
