**SUBJECT: CIVIL SERVANTS (DISCLOSURE AND REGULATION OF FOREIGN NATIONALITY) RULES 2026 AND DECLARATION REGARDING FOREIGN NATIONALIITY/FOREIGN TRAVEL DOCUMENTS WITHIN 90 DAYS**

The undersigned is directed to enclose herewith Establishment Division OM No. 3/1/2025-D-IV dated 4th June, 2026 wherein it is informed that the Prime Minister has been pleased to approve the Civil Servants (Disclosure and Regulation of Foreign Nationality) Rules, 2026 notified vide S.R.O No. 893(I)/2026 dated 1st June, 2026, which may kindly be disseminated for information.

2. Further, Establishment Division vide OM No. 3/1/2025-D-IV dated 4th June, 2026 forwarded a proforma prescribed under Para-3(3) of Rules *ibid*, regarding Declaration of Foreign Nationality/Foreign Travel Documents, which states that "*Within ninety days after these rules are notified in the official Gazette all civil servants shall make a declaration in a format or manner to be specified by the Establishment Division, as to them and their dependents' status regarding nationality of any foreign country, holding any foreign country travel document and marriage with a foreign national*".

3. The competent authority has desired to collect the requisite data/information. Therefore, it is requested that information/data of all Departmental Cadre Staff (BS 1-18) on the prescribed format may be collected and a Certificate regarding completion of declaration, may be furnished to this office positively within seven (07) working days.
