

**Subject: GUIDELINES FOR NOMINATIONS OF BS-20 OR EQUIVALENT OFFICERS FOR NATIONAL SECURITY & WAR COURSE AT NATIONAL DEFENCE UNIVERSITY, ISLAMABAD**

The undersigned is directed to refer to the Establishment Division's O.M. F.No.2/3/2025-1-1 dated 10-06-2025 on the subject whereby the following additional guidelines have been issued regarding nominations for NS&WC, in addition to criteria & conditions circulated for each course from time to time:

- (i) If any officer who is nominated for NMC as per seniority for the first-time, requests Establishment Division for a nomination to NS&WC instead of NMC, such a request can be considered by that Division, subject to the laid down criteria for nominations for NS&WC. The officer concerned shall invariably endorse a copy of his/her request for nomination for NS&WC to his/her concerned department.
- (ii) Once the officer is nominated for NS&WC by Establishment Division, he/she shall not be considered for the next NMC(s), till the time final selection of the officer for NS&WC is conveyed by the NDU.
- (iii) If any officer is selected for NS&WC by the NDU, it will be mandatory for him/her to join the course as he/she shall not be considered for nomination in NMCs, subsequently. Further, concerned Ministry/Division/Provincial Governments etc shall be bound to relieve the officers to attend the NS&WC course, without fail.
- (iv) An officer, who is selected for NS&WC by NDU shall not submit any request for deferment, including requests from concerned department for his/her withdrawal from the NS&WC.
- (v) Based on the request as per para (i), if any officer nominated for NS&WC by that Division is subsequently not selected by the NDU, for any reason, the officer concerned will be nominated for the immediately next NMC training.
- (vi) Additional nominations for NS&WC which are received at belated stage or received once the panel for NS&WC is finalized by Establishment Division, shall not be considered.
