
4. Following instructions may kindly be observed while sending the requisite information to this office to avoid future complications: -

- Date of regular promotion does not mean date of promotion on acting charge basis.
- All dates must be written in **Alpha Numeric Format e.g. (01-Jan-2025)**.
- If any discrepancy is pointed out at later stage, the FAO concerned shall be held responsible.
- In case of any ambiguity in enclosed proformas, undersigned may be contacted.

5. All the Regional Chairmen DPCs are requested **not to hold** DPC meetings till finalization of the Combined Seniority Lists of each cadre.


