NOTIFICATION


The Senior Auditors / Asstt. Audit Officers nominated for PIPFA (Public Sector) certification will henceforth, have to pay the prescribed coaching, exemption and examination fee for each level as per discounted rates admissible in DAGP (**Annexure-A**). All these charges will be reimbursed on passing the examination at each complete level. The registration fee will be paid by the Govt. of Pakistan. However, if a candidate leaves PIPFA midway or leaves it altogether for any reason, the registration fee will be recovered from his/her salary.

2. The Senior Auditors (BPS-16) and Junior Auditors (BPS-11), who have one (1) year regular service, will be eligible to take the PIPFA (Public Sector) examination as per conditions laid down by PIPFA.

3. However, Junior Auditors, will be eligible to take PIPFA (Public Sector) examination only on **self-finance** basis subject to approval of the Auditor-General and PIPFA Public Sector qualification shall give no advantage to them in their seniority viz-a-viz their seniors and shall not confer any right upon them for out of turn promotion. Every candidate applying to become a registered student of PIPFA (Public Sector) must produce a certificate from the head of his/her department/office stating that he/she meets the admission criteria.

4. The candidates should opt for PIPFA training /examination center at or near the duty station i.e. Islamabad, Lahore, Karachi, Quetta and Peshawar.

5. All the other terms and conditions regarding nomination for PIPFA certification will remain the same. The reimbursement policy will be applicable w.e.f Summer-2025 session.


