SPEAKING ORDER


A hearing was granted to the appellant i.e. **Mr. Zaheer Babar Warriach**, Ex-BS-18 PA&AS officer on July 19, 2022 in compliance of Federal Service Tribunal Islamabad's orders dated May 23, 2022 in Appeal No. 621(R)CS/2018. During the hearing Mr. Warriach reiterated that as per his record, he should have been promoted to BS-19, in pursuance of recommendations of Departmental Selection Board (DSB) which held its meeting on December 12, 2007.

2. Case of Mr. Zaheer Babar Warriach was considered for promotion in meeting held on January 19, 2005 and DSB superseded him for being absent. Earlier DSB in its meeting held on September 20, 2003 deferred his promotion as his PERs from 1994 to 2003 were still awaited; not available in office.

3. DSB met again on December 12, 2007 and after going through his record and PERs recommended to promote Mr. Zaheer Babar Warriach, as per the prescribed criteria for promotion to BS-19. However, his promotion notification, even after approval of DSB-minutes, was not issued.

4. I have gone through personal file / ACR dossier / Legal Branch's record and have come to the conclusion that he was rightly recommended for promotion for BS-19 by DSB in 2007 (based on officer's record upto 2006) and such promotion should have been notified. I did not find anything which is inscrutable.

5. Accordingly, Mr. Zaheer Babar Warriach be notified as promoted to BS-19 w.e.f. March 8, 2008 i.e. from the date other recommendees were notified in BS-19 in pursuance of recommendations of DSB meeting dated December 12, 2007.
