

Subject: **REFERENCE TO TERRORIST ORGANIZATIONS IN BALOCH STAN AS FITNA AL HINDUSTAN IN OFFICIAL CORRESPONDENCE AND DOCUMENTS**

Keeping in view the involvement of some Organizations and Groups in Terrorist activities in Balochistan, at the behest of India (Hindustan), which are detrimental to Islamic faith and sovereignty of Pakistan, and customary traditions, it has been decided that, henceforth, all Terrorist Groups and Organizations operating in Balochistan will be referred to as "Fitna al Hindustan". 2. All Government entities are directed to start the above practice immediately. This shall also be circulated to all Departments and entities under the administrative control of Federal Ministries/Divisions and other Governments.
