

**OFFICE MEMORANDUM**

**SUBJECT: WITHDRAWALS FROM MANDATORY TRAINING COURSES (MCMC/ SMC/ NMC & NSWC)**

The undersigned is directed to refer to this Division's O.M F.No.8/5/2024-T-VI dated 20<sup>th</sup> September 2024 and O.M No.8/7/2024-T-VI dated 19<sup>th</sup> December, 2024 on the above subject. The following directions of the competent authority regarding nominations for mandatory training courses may be noted for general information and compliance: -

- a. Any requests for withdrawal must be furnished to this Division at least two weeks before the commencement of training so that alternate arrangements can be made in a timely manner;
  - b. After three withdrawals from a given training course, the concerned officer, presumably performing extremely indispensable work, will *not* be nominated in the next courses, *indefinitely*.
  - c. However, if the said officer or his controlling ministry or government, at some later stage, decides that the officer may join the mandatory training, such request may be furnished to this division at least fifteen days before the commencement of the training through proper channel.
  - d. After such request is received in time, it shall be up to the competent authority to allow the said officer to be nominated in the coming course in a later one, having considered the administrative concerns and legitimate expectations of other officers who have fallen in line for nomination for the coming training.
2. This above dispensation shall be applicable immediately.
