PREFACE

Articles 169 and 170 of the Constitution of the Islamic Republic of Pakistan, 1973 read with Sections-8 and 12 of the Auditor-General's (Functions, Powers and Terms and Conditions of Service) Ordinance, 2001 and Section 168 of Local Government Act 2012, require the Auditor-General of Pakistan to conduct audit of the receipts and expenditure of Local Fund of District Council and Municipal Committees.

The report is based on audit of the accounts of Distrit Council and Municipal Committees, District Abbottabad for the Financial Year 2013-14. The Directorate General of Audit, District Governments, Khyber Pakhtunkhwa, Peshawar conducted audit on test check basis during 2014-15 with a view to reporting significant findings to the relevant stakeholders. The main body of the Audit Report includes only the systemic issues and audit findings carrying value of Rs. 1 million or more. Relatively less significant issues are listed in the Annexure-1 of the Audit Report. The Audit Observations listed in the Annexure -1 shall be pursued with the Principal Accounting Officer at the DAC level and in all cases where the PAO does not initiate appropriate action, the Audit observation will be brought to the notice of Public Accounts Committee through the next year's Audit Report.

Audit findings indicate the need for adherence to the regularity framework besides instituting and strengthening internal controls to avoid recurrence of similar violations and irregularities.

The observations included in this report have been finalized in the light of written replies of the Departments. DAC meeting could not be convened despite repeated requests.

The Audit Report is submitted to the Governor of Khyber Pakhtunkhwa in pursuance of Article 171 of the Constitution of the Islamic Republic of Pakistan, 1973 read with Section 168 of Khyber Pakhtunkhwa Local Government Act 2012 to be laid before appropriate legislative forum.

EXECUTIVE SUMMARY

The Directorate General Audit, District Governments, Khyber Pakhtunkhwa, Peshawar, is responsible to conduct the audit of all District Councils, Municipal Committees (MCs) and Union Councils (UCs). Its Regional Directorate of Audit Abbottabad has audit jurisdiction of District Councils, Municipal Committees and UCs six Districts i.e. Abbottabad, Haripur, Mansehra, Battagram, Kohistan and Tor Ghar.

The Regional Directorate has a human resource of 13 officers and staff, constituting 3,939 man days and a budget of about Rs 14.747 million was allocated during 2014-15. It has the mandate to conduct financial attest audit, audit of sanctions, audit of compliance with authority and audit of receipts as well as the performance audit of entities, projects and programs. Accordingly Regional Director Audit Abbottabad carried out audit of the accounts of Distrit Coucil and Municipal Committees Abbottabad for the Financial Year 2013-14 and the findings included in the Audit Report.

District Council and Municipal Committees District Abbottabad conduct their operations under Khyber Pakhtunkhwa Local Government Act 2012. Administrative Secretary i.e Secretary Local Government and Rural Development Department, Khyber Pakhtunkhwa is the Principal Accounting Officer for these local bodies. According to financial provisions of the Act the Secretary Local Government and Rural Development Department, Khyber Pakhtunkhwa authorizes the Annual Budget Statement for these local bodies in the form of budgetary grants.

a. Scope of Audit

Out of the total expenditure of District Council and Municipal Committees Abbottabad, for the Financial Year 2013-14, the auditable expenditure under the jurisdiction of RDA was Rs 356.167 million. Out of this, RDA Abbottabad audited expenditure of Rs 213.700 million which, in terms of percentage, was 60% of auditable expenditure.

The receipts of District Council and Municipal Committees Abbottabad for the Financial Year 2013-14 were Rs 308.629 million. Out of this, RDA Abbottabad audited receipts of Rs 154.315 million which, in terms of percentage, is 50% of auditable receipts.

The total expenditure and receipt of District Council and Municipal Committees, District Abbottabad, for the Financial Year 2013-14 were Rs 664.796 million. Out of this, RDA Abbottabad audited the expenditure and receipts of Rs 352.342 million.

b. Recoveries at the instance of Audit

Recovery of Rs 21.054 million was pointed out during the audit. However, no recovery was affected till the finalization of this report. Out of the total recoveries Rs 5.295 million was not in the notice of the executives before audit.

c. Audit Methodology

Audit was conducted after understanding the business processes of District Council and Municipal Committees, District Abbottabad, with respect to its functions, control structure, prioritization of risk areas by determining their significance and identification of key controls. This helped auditors in understanding the systems, procedures, environment, and the audited entity before starting field activity. Audit used desk audit techniques for analysis of compiled data and review of permanent files/record. Desk Audit greatly facilitated identification of high-risk areas for substantive testing in the field.

d. Audit Impact

Audit pointed out various irregularities of serious nature to the management. However, no impact was visible as the management failed to reply and the irregularities could not come to the light in the proper forum i.e DAC.

e. Comments on Internal Control and Internal Audit department

The purpose of internal control system is to ensure effective operation of an organization. It consists of measures employed by the management to achieve objectives, safeguard assets, ensure accuracy, timeliness and reliability of financial and accounting information for decision making.

One of the basic components of Internal Control System, as envisaged under Para 13 of GFR Volume-I, is internal audit which was not found prevalent in District Council and Municipal Committees, District Abbottabad. Neither rules for internal audit have been framed nor internal audit report as required was provided to audit.

f. Key audit findings of the report;

- i. Irregularity & Non-compliance of Rs 19.098 million was noted in eleven cases.¹
- ii. Loss due to weak internal control of Rs 11.221 million was noted in four cases.²

g. Recommendations

- i. Disciplinary action needs to be taken for non production of record as well as violation of the rules and regulations in spending the public money.
- ii. Concerted efforts need to be made to recover long outstanding dues.
- iii. Deduction of taxes on supplies and contracts need to be ensured.
- iv. Inquiries need to be held to fix responsibility for losses, irregular payments and wasteful expenditure.

CHAPTER-1

1.1 District Council & Municipal Committees District Abbottabad

1.1.1 Introduction

District Abbottabad has two tehsils i.e. Abbottabad and Havelian. There is a District Council and two Municipal Committees. District Council has a Chief Coordination Officer, District Officer (Finance), District Officer (Infrastructure) and District Officer (Regulation). Municipal Committees have Chief Municipal Officers, Municipal Officers (Finance), Municipal Officers (Infrastructure) and Municipal Officers (Regulation). District Council Abbottabad has one Drawing and Disbursing Officer (DDO) i-e. Chief Coordination Officer & Chief Municipal Officers are the DDOs of Municipal Committees. According to 1998 population census, the population of District Abbottabad is 977,212.

1.1.2 Comments on Budget and Expenditure (variance analysis)


An amount of Rs 393.390 million was allocated as grant in aid by the Provincial Government to District Council and Municipal Committees of District Abbottabad. An amount of Rs 154.315 was realized during the financial year 2013-14. Thus making a total of Rs 547.705 million at the disposal of local councils, against which an expenditure of Rs 356.167 million was incurred by the District Council and Municipal Committees Abbottabad with a saving of Rs 191.538 million during financial Year 2013-14. Detail is given below:

The huge savings of Rs 345.852 million in all heads of accounts indicate weakness in the capacity of these local institutions to utilize the amounts allocated.

1.1.3 Comments on the status of compliance with ZAC/PAC Directives

The audit reports on the accounts of newly formed District Council and Municipal Committees Abbottabad under the LGA 2012, have not yet been discussed in PAC.

DISTRICT COUNCIL ABBOTTABAD

1.2 Audit Paras District Council Abbotabad

1.2.1 Irregularity & Non Compliance

1.2.1.1 Non recovery of property rent – Rs 1.312 million

As per Para 8 and 26 of the General Financial Rules Volume I, each administrative department is to see that the dues of the Government are correctly and promptly assessed, collected and paid into Government Treasury.

Chief Coordination Officer Abbottabad failed to collect various property rent from the tenants during the year 2013-14 as per detail given below:

Similarly Chief Coordination Officer, Abbottabad awarded different contracts to the contractors during the year 2013-14 (Annex-4).

However, Professional Tax was not deducted from the contractors. Non deduction of Professional tax resulted into loss to Government of Rs 186,400.

Chief Coordination Officer, Abbottabad failed to deduct house rent from salaries of various employees residing in residential quarters aggregating to Rs 244,241 during 2013-14.

Non recovery of rent occurred due to non compliance of rules, which resulted into loss to Government.

When pointed out in August 2014, management stated that notices have been issued to all concerned for recovery. However no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery and action against the person(s) at fault under intimation to audit.

AP 01, 04 & 08 (2012-13)

1.2.1.2 Non recovery of annual lease – Rs 1.638 million

According to clause-2 of the contract agreement of Shimla Hill Park, the contractor will pay annual installment of lease on 15th July of each year, otherwise lease will stand cancelled with a one month prior notice to the contractor.

Chief Coordination Officer, Abbottabad failed to collect annual lease of Shimla Hill amounting to Rs 1,638,000 from the contractor till June, 2014. The local office neither recovered the amount from contractor nor the lease was cancelled in light of above clause of agreement.

Non recovery of annual lease occurred due to non compliance of rules, which resulted into loss of Rs 1,638,000.

When pointed out in August 2014, management stated that the said lessee was served with several notices and finally he was black listed, which was challenged in Honorable court. However, no documentary evidence in support of reply was provided.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends full recovery of lease amount besides action against the person(s) at fault.

AP 06 (2013-14)

1.2.1.3 Non recovery of water user charges – Rs 2.035 million

Para 26 of GFR Vol-I requires that it is the duty of the Departmental Controlling Officer to see that all sums due to Government are regularly and promptly assessed, realized and duly credited in the Public Account.

Chief Coordination Officer, Abbottabad failed to recover water rates amounting to Rs 2,034,739 from the users of service centre Nawanshehr during the year 2013-14 as detailed below

Water user charges were not recovered due to non compliance of rules, which resulted in loss to public exchequer.

When pointed out in August 2014, management stated that notices have been issued to the concerned and all the dues would be recovered during the financial year 2014-15. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery of charges besides action against the person(s) at fault.

AP 07 (2013-14)

1.2.1.4 Non imposition of penalty – Rs 1.084 million

Clause 6 of the work order and Clause 2 of the Contract Agreement requires that penalty of 1% per day and up to maximum of 10% of the tender cost may be imposed for delay in completion of work.

Chief Coordination Officer, Abbottabad awarded various developmental works to different contractors aggregating to Rs 10,838,000. The Contractors did not complete the works in stipulated period of time. 10% penalty amounting to Rs. 1,083,800 was required to be imposed and recovered from the concerned contractors, which was not done (detail given at annex-5).

Penalty was not imposed due non compliance of rules, which resultd into loss to Government.

When pointed out in August 2014, management stated that penalty would be imposed according to rules on completion of the schemes. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends imposition and recovery of penalty amount from the concerned contractors beside action against the person(s) at fault.

AP 11 (201314)

1.2.1.5 Non recovery of dues – Rs 2.717 million

As per Para 8 and 26 of the General Financial Rules Volume I, each administrative department is to see that the dues of the Government are correctly and promptly assessed, collected and paid into Government Treasury.

Chief Coordination Officer Abbottabad failed to collect various arrears from different contractors on account of different contracts aggregating to Rs 2,716,689 up to June, 2014 as detail below:

Non recovery of arrears of auctions occurred due to non compliance of rules, which resulted into loss of Rs 2.717 million.

When pointed out in August 2014, management stated that actual possession of the contact was handed over to the contractor on 16-07-2013 and recovery was accordingly made. The reply is not tenable as complete amount was not recovered.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends complete recovery from the concerned besides action against the person(s) at fault.

AP 22 (2013-14)

1.2.2 Internal Control Weaknesses

1.2.2.1 Non energization of schemes amounting to – Rs 4.100 million

Para 10 (i) of GFR Vol-I provides that every public officer is expected to exercise the same vigilance in respect of expenditure incurred from public moneys, as a person of ordinary prudence would exercise in respect of expenditure of his own money.

Chief Coordination Officer, Abbottabad made payment of Rs 1.700 million and Rs.2.400 million in two different schemes to PESCO for provision of TF/HT//LT lines and other electrification works during 2013-14. No progress regarding energization of schemes was found on record till the date of audit i.e 19-08-2014.

Non energization of schemes occurred due to weak internal control.

When pointed out in August 2014, management stated that PESCO authorities have been asked to submit progress report of these works. No progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends immediate energization of schemes and action against the person(s) at fault.

AP 18 (2013-14)

1.2.2.2 Wastage of Government money amounting to – Rs 3.064 million

Para 10 (i) of GFR Vol-I provides that every public officer is expected to exercise the same vigilance in respect of expenditure incurred from public moneys, as a person of ordinary prudence would exercise in respect of expenditure of his own money.

There were three guest houses working under the administrative control of Chief Coordination Officer, Abbottabad. The comparison of income and expenditure of these guest houses during the year 2013-14 is given below:

The local office incurred an expenditure of Rs 3,254,942 whereas income generated from these rest houses was Rs 191,034, which resulted into loss of Rs 3,063,908.

These rest houses are a constant source of loss. Expenditure on these guest houses occurred due to weak internal control system.

When pointed out in August 2014, management stated that the expenditure was incurred to keep the rest house in order and functional during the summer season. The reply is not tenable as expenditure in excess of receipts resulted in loss.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends detail inquiry into the matter and action against the person(s) at fault.

AP 05 (2013-14)

MUNICIPAL COMMITTEE ABBOTTABAD

1.3.1 Irregularity & Non compliance

1.3.1.1 Non recovery of Conservancy Charges – Rs 2.180 million

According to Notificationon No. 1372/T TMA Dated. 26-04-2012 Conservancy charges were required to be collected from different departments.

Chief Municipal Officer Abbottabad did not collect monthly Conservancy Charges amounting Rs 2,179,780 from different departments and other commercial institutions during the year 2012-13.

Non recovery of conservancy charges was occurred due to non compliance of rules, which resulted into loss of Rs 2.180 million.

When pointed out in November 2014, management stated that necessary recovery would be made from the concerned persons in due course of time. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Accounint Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery besides action against the person(s) at fault.

AP 50 (2013-14)

1.3.1.2 Non recovery of property rent – Rs 1.507 million

As per Para 8 and 26 of the General Financial Rules Volume I, each administrative department is to see that the dues of the Government are correctly and promptly assessed, collected and paid into Government Treasury.

Chief Municipal Officer Abbottabad failed to collect various property rents from the tenants during the year 2013-14 as per detail given below:

Rent was not recovered due to non compliance of rules, which resulted into loss of Rs 1.507 million.

When pionted out in November 2014, management stated that recovery would be made from the occupants. However, no progess was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery besides action against the person(s) at fault.

AP 51 (2013-14)

1.3.1.3 Non recovery of arrears of rent of vegetable market – Rs 1.995 million

As per Para 8 and 26 of the General Financial Rules Volume I, each administrative department is to see that the dues of the Government are correctly and promptly assessed, collected and paid into Government Treasury.

Municipal Officer Abbottabad did not collect various property rents from the tenants of shops, phatta holders, Rehris, and Cabins during the year 2013-14 as per detail given below:

Similarly Municipal Officer Abbottabad also failed to recover advertisement fee / sign board charges amounting to Rs 165,150 from various advertisement agencies during the year 2013-14.

Non recovery of property rent and advertisement charges was occurred due to non compliance of rules.

When pionted out in November 2014, management stated that arrears would be recovered from the defaulters in due course of time. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Accounint Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery besides action against the person(s) at fault.

AP 52 &53 (2013-14)

1.3.1.4 Non recovery of outstanding water user charges – Rs 1.516 million

Para 26 of GFR Vol-I requires that it is the duty of the Departmental Controlling Officer to see that all sums due to Government are regularly and promptly assessed, realized and duly credited in the Public Account.

Chief Municipal Officer, Abbottabad failed to recover water rates amounting to Rs 1,516,150 from the users up to 2013-14.

Non recovery of outstanding water charges occurred due to non compliance of rules, which resulted in loss to public exchequer.

When pointed out in November 2014, management stated that recovery would be made from the connections holders in due course of time. However, no progess was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery besides action against the person(s) at fault.

AP 54 (2013-14)

1.3.1.5 Non recovery of Government dues – Rs 1.954 million

As per Para 8 and 26 of the General Financial Rules Volume I, each administrative department is to see that the dues of the Government are correctly and promptly assessed, collected and paid into Government Treasury.

Chief Municipal Officer Abbottabad did not collect arrears from various contractors on account of different contracts aggregating to Rs 1,953,879 during 2013-14 as detail below:

Non recovery of arrears of auctions occurred in violation of rules, which resulted into loss of Rs 1.954 million.

When pointed out in November 2014, management stated that recovery would be made from the contractors. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery from the concerned besides action against the person(s) at fault.

AP 55 (2013-14)

1.3.1.6 Non imposition of penalty – Rs 1.160 million

According to work order, the works shall be completed upto 30-06-2014 otherwise, 10% penalty shall be imposed on default contractors for delay in completion of works.

Chief Municipal Officer Abbottabad awarded twenty one (21) developmental schemes to various contractors amounting to Rs 11.600 million during 2013-14. The work orders were issued in March 2014 with completion period in June 2014. However, the contractors failed to complete the schemes within stipulated period of time i,e up to June, 2014. The competent authorities did not impose penalty amounting to Rs 1,160,000 on concerned contractors for delay in completion of works. Detail is given at Annexure-3.

Non imposition of penalty occurred due to non compliance of rules, which resulted in loss to Government.

When pointed out in November 2014, management stated that action would be taken against the concerned contractors after finalization of schemes. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends recovery of penalty and action against the person(s) at fault.

AP 63 (2013-14)

1.3.2 Internal Control Weaknesses

1.3.2.1 Non deposit of tender form fee – Rs 1.655 million

Treasury Rule 7(i) states that all the money received by or tendered to Government officers on account of the revenue shall without undue delay be paid in full into a treasury.

Chief Municipal Officer Abbottabad realized Rs 1,614,400 on account of sales of tender forms during 2013-14. However, the local office deposited only Rs 311,570 and the balance amount of Rs 1,302,830 was not deposited. Detail is given at annexure-7.

Similarly Chief Coordination Officer, Abbottabad collected an amount of Rs 352,500 on account of sale of tender form fee from various contractors of different developmental schemes pertaining to PFC,ADP and DLF during the year 2013-14. The same was deposited into council bank account which was required to be deposited into Government treasury.

Non deposit of Government money occurred due to weak internal control system.

When pointed out in August 2014, management stated that tender forms were purchased out of the District Council fund, as such the income received from the sale of tender forms is being deposited under proper head in District Local Funds. The reply is not tenable as complete amount was not deposited.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends immediate depositing the tender form fee besides action against the person(s) at fault.

AP 66 & 13 (2013-14)

1.3.2.2 Non energization of schemes – Rs 2.402 million

Para 10 (i) of GFR Vol-I provides that every public officer is expected to exercise the same vigilance in respect of expenditure incurred from public moneys, as a person of ordinary prudence would exercise in respect of expenditure of his own money. Chief Municipal Officer Abbottabad paid of Rs 2,100,000 to PESCO as advance payment for energization of different schemes in different areas during the year 2013-14. However, no progress was reported.

Similarly Chief Municipal Officer Abbottabad also failed to adjust advances allowed to different employees for execution of various works out of local fund aggregating to Rs 302,250 during the year 2013-14. Concerned employees neither adjusted these advances nor did the local office recover the amount from them.

Non energization of schemes and non adjustment of advances occurred due to weak internal control.

When pointed out in August 2014, management stated that PESCO authorities have been asked to submit progress report of these works. However, no progress was reported.

Request for convening of DAC meeting was made on 24-11-2014, but no response was received from the Principal Account Officer, as a result DAC meeting could not be convened till finalization of this report in January 2015.

Audit recommends immediate energization of schemes and action against the person(s) at fault.
