# **PREFACE**

The Auditor General of Pakistan conducts audit in accordance with Articles 169 and 170 of the Constitution of the Islamic Republic of Pakistan 1973, read with Sections 8 and 12 of the Auditor General's (Functions, Powers and Terms and Conditions of Service) Ordinance 2001. The Performance Audit on "Improvement in service delivery due to merit based/school based recruitment policy for teaching cadre in Education Department Abbottabad" was carried out accordingly.

The Directorate General Audit, District Governments, Khyber Pakhtunkhwa conducted performance audit on "Improvement in service delivery due to merit based/school based recruitment policy for teaching cadre in Education Department Abbottabad" for the period from 2014-15 to 2018-19 during January 2020 with a view to report significant findings to stakeholders. Audit examined the economy, efficiency and effectiveness aspects of the recruitment of teaching staff through NTS. Audit also assessed, on test check basis, whether the management complied with the applicable laws, rules and regulations during recruitment of teaching staff. The Audit report indicates specific actions that, if taken, will help the management to realize the objectives of recruitment policy.

Most of the observations included in this report have been finalized in the light of written responses and discussions with the management. DAC meeting could not be arranged despite repeated reminder.

The Audit Report is submitted to the Governor of Khyber Pakhtunkhwa in pursuance of Article 171 of the Constitution of the Islamic Republic of Pakistan 1973, for causing it to be laid before the Provincial Assembly of Khyber Pakhtunkhwa.

# **EXECUTIVE SUMMARY**

The Directorate General Audit, District Governments, Khyber Pakhtunkhwa conducted performance audit on "Improvement in service delivery due to merit/school based recruitment policy for teaching cadre in District Education Department Abbottabad, Khyber Pakhtunkhwa" during January, 2020. The main objective of audit was to analyze impact on service delivery due to merit/school based recruitments of teachers in terms of economy, efficiency and effectiveness. The audit was conducted in accordance with INTOSAI Auditing Standards as adopted by the Department of the Auditor General of Pakistan.

The process of recruitment of teachers on adhoc/contract basis within cluster of schools in Elementary and Secondary Education Department was initiated in 2014 in compliance to the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, lecturers, Instructors and Doctors) Regulatory Act, 2011. It stipulates that vacancy of primary school teacher shall be filled in from the candidates belonging to the Union Council of their permanent residence mentioned in their Computerized National Identity Card and domicile, on merit and if no eligible candidate in that Union Council is available where the school is situated, such appointment shall be made on merit from amongst eligible candidates belonging to the adjacent Union Councils. The teachers were hired through National Testing Service with the basic aim to end the +shortage of teachers and speeding up the recruitment process, which otherwise took a long time when carried out through Public Service Commission. From 2014 till 2019, Elementary and Secondary Education department recruited around 40,000 teachers on adhoc/contract basis through merit/school based recruitment policy from the parent union council or adjacent union council. However, during election year 2018, the services of the adhoc teachers were regularized under the "The Khyber Pakhtunkhwa employees of the Elementary & Secondary Education Department (Appointment and Regularization of Services) Act, 2017".

# **Key Audit Findings**

Key Audit findings are as follows:

- i. Irregular appointments of 381 male and 319 female teachers in various categories without conducting any interview and considering the requisite experience. (Para- 4.1.1)
- ii. In violation of the Rationalization Policy, 121 Govt; Primary Schools and 80 Govt; Girls Primary Schools having 4229 and 3217 students respectively were managed by a single teacher instead of two. (Para- 4.2.1)
- iii. 97 teachers were short in 87 Govt; Primary Schools and 61 teachers were short in 45 Govt; Girls Primary Schools having 15,590 and 9,204 students respectively. While 83 teachers in 85 Govt: Primary schools and 107 teachers in Govt; Girls primary schools were surplus but the same was not adjusted/rationalized in those schools where teachers were short (Para- 4.2.2)
- iv. Basic facilities i.e., electricity, water, toilets and boundary walls were not available in 293 primary and middle schools where 20,849 students admitted (Para-4.3.1)
- v. Children out of schools ratio increased from 13% to 22% at primary level. The enrollment of students in Government primary schools declined from 92,861 to 74,380 despite the appointment of 700 teachers (Para-4.4.1&4.4.2).
- vi. Student learning outcomes were below standards (Para-5.1.1).

## Recommendations

Audit recommends that:

- i. The appointments should be made in the light of ESTA Code.
- ii. The rationalization policy should be implemented in true letter and spirit.
- iii. Missing basic facilities in schools should be provided to secure the future of children.
- iv. Efforts should be made to achieve the targets.
- v. SLO should be brought at par with the standard.

# 1. INTRODUCTION

# 1.1 Background

The Director General Audit, District Governments, Khyber Pakhtunkhwa conducted performance audit on "Improvement in service delivery due to merit based/school based recruitment policy for teaching cadre in Education Department Abbottabad" during January, 2020. The main objective of audit was to evaluate the impact of merit based/school based recruitment policy in education department. The audit was conducted in accordance with INTOSAI Auditing Standards as adopted by the Department of the Auditor General of Pakistan.

Article 25-A of Constitution of Pakistan stipulates "The State shall provide free and compulsory education to all children of the age of five to sixteen years in such a manner as may be determined by law" which makes it obligatory on the State to provide free and compulsory quality education to children of the age group 5 to 16 years. Subject of Elementary and Secondary Education is devolved to Districts/Tehsils as mentioned in the list of devolved offices of First Schedule of Local Government (amendment) bill, 2019, which makes it binding on the District Education Offices to implement policies and procedures of E&SE Department of Khyber Pakhtunkhwa as devised under constitutional obligations. Over the last 5 years, Provincial Government had reformed the terms and conditions of teachers, which also included recruitment rules, with the intention to shape the entire teacher performance environment. It was believed that robust and mutually beneficial terms and conditions for teachers could encourage good candidates to enter the profession, and could reward merit throughout a teachers' career, ultimately resulting in improved teaching standards and enhanced student learning outcomes. Under this backdrop, merit (NTS) and school based recruitment policy was introduced and teaching cadre up to BPS-15 were recruited through District Education Offices in each district. This policy and results thereafter need to be scrutinized to assess that whether such results were achieved.

# 1.2 Organizational Structure

District Education Office (Male & Female) Abbottabad is headed by District Education Officer. District Education Officer is assisted by Deputy District Education Officer and Sub-Division Education Officer. DDEO is further assisted by ADEO establishment, ADEO P&D and ADEO Sports while ASDEO is assisted by ASDEOs circle.

# 2. AUDIT OBJECTIVES

The major objectives of the audit were to ascertain whether the:

- Level of observance of recruitment policy during recruitment process was sound.
- Iimprovement in service delivery due to merit based/school based recruitment policy in education department through NTS was achieved.
- Criteria set for recruitment of teachers up to BPS-15 was complied with or not.
- Rationalization policy of teachers for ascertaining demand of teachers in the public schools was executed.
- Improvement in the learning landmarks of students during various assessment exercises held at various Grades through internal and external organizations was achieved.

# 3. AUDIT SCOPE AND METHODOLIGY

# **Audit Scope**

Audit focused on role and efforts made by District Education Office (Male & female) Abbottabad for improvement in service delivery due to merit based/school based recruitment policy in education department through NTS w.e.f., 2014 to 2019.

## **Documents Review**

Documents were reviewed to gain an understanding of the impact of recruitment policy of education department on overall education progress. Some of the documents reviewed were:

- Recruitment policy
- Rationalization policy
- Annual school census reports
- EMIS/IMU Data
- Reconciled expenditure statements
- Districts Performance Scorecards

# **Audit Methodology**

The audit was conducted in accordance with International Organization of Supreme Audit Institutions (INTOSAI) Auditing Standards as adopted by the Department of the Auditor General of Pakistan. These standards require comprehensive planning to ensure that an audit of high quality is carried out in an economic, efficient and effective way within the planned time and cost. Data was collected from both primary and secondary sources.

The District Education Officers (Male & Female) were visited by the audit team to gather information through interviews from the management of the department and to review the documents and other related records. Information was

also collected from the websites of Independent Monitoring Unit (IMU), Education Management Information System (EMIS) and Elementary and Secondary Education Department Khyber Pakhtunkhwa. Moreover, statistical reports of the government schools as carried out the department from 2014 till date were also consulted to have better understanding of the reforms introduced by the government from time to time.

# 4. AUDIT FINDINGS AND RECOMMENDATIONS

# 4.1 Organization and management

# 4.1.1 Irregular appointment of teachers

According to clause c & d of Establishment Department's circular letter No. SORI(S&GAD) 4-1/75 (Vol-I), 26.5 2000, in addition to the total marks allocated for a written competitive examination, if any held, the total marks will be 100 as per distribution i.e. (a) Prescribed qualification- 70, (b) Higher qualification- 12 marks, (c) Experience-10 marks and (d) Interview-08 marks.

Scrutiny of appointments record of District Education officers (Male & Female) Abbottabad between 2014 and 2019 revealed that 700 teachers (381 male & 319 female) were appointed without interview and requisite experience.

The irregular appointments occurred due to weak administrative controls and resulted in violation of rules.

When pointed out in March 2020, the management stated that all appointments between 2014-2019 of teachers fall in the domain of undersigned were made in the light of NTS policy. There is no such provision for experience and interview.

Reply was not cogent as no such evidence was provided that the subject policy was either approved or endorsed by establishment department. Moreover management admitted that appointment was made without interview and considering experience.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends that the appointments should be made in the light of ESTA code.

# 4.2 Rationalization Policy

# 4.2.1 Non-maintaining of minimum teacher/student ratio

According to Elementary & Secondary Education Department Khyber Department Pakhtunkhwa letter No. 6104-59/Rationalization/Estab dated 01.04.2014, each primary school will have one post of PSHT B-15 and one post PST B-12.

Scrutiny of schools record of DEO (Male & Female) Abbottabad in the light of Rationalization Policy revealed that 201 Govt; Primary Schools with 4229 boys and 3217 girl students were being managed by a single teacher instead of at least two per primary school. Detail is given at Annexure-1 & 2.

Non-maintaining of minimum teacher/student ratio occurred due to lack of planning and weak administrative controls and resulted in depriving students of quality education.

When pointed out in March 2020, the management stated that the gape of teacher student ratio will be covered through appointment of (380) PSTs which is in progress.

Management admitted that the appointments of teachers are in progress to maintain minimum teacher student ratio. However no progress was shown till finalization of this report.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends appointment/posting of teachers immediately for providing quality education to community.

# **4.2.2** Non-implementation of Rationalization Policy

According to Elementary & Secondary Education Department Khyber Department Pakhtunkhwa letter No. 6104-59/Rationalization/Estab dated 01.04.2014, in primary schools the teacher/students ratio shall be 1:40.

Scrutiny of schools record of DEO (Male & Female) Abbottabad in the light of Rationalization Policy revealed that there was a dearth of 184 teachers in Govt; Primary Schools having 24794 students (girls and boys both). Detail is given at annexure-3. Whereas 190 teachers, on the other hand were in surplus in 85 other schools and were not being adjusted under the policy. Detail is given at Annexure-4.

Non-implementation of Rationalization Policy occurred due to weak administrative controls and resulted in poor student's performance in exams.

When pointed out in March 2020, the management stated Rationalization Policy is being implemented through appointment of teachers in pipeline.

Reply was not cogent as excess teachers were not adjusted in the light of rationalization policy.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends the implementation of rationalization policy.

# 4.3 Construction and works

# 4.3.1 Non-availability of basic facilities in the schools

According to Chapter 10 of Minimum Standards for Quality Education Policy 2016 read with clause 117 of National Education Policy 2009, each school must have drinking water, 2-3 toilets for students, lighting, boundary wall and adequate seating facilities. Furthermore, according to Government of Khyber Pakhtunkhwa Elementary & secondary Education Department Notification No. CPO/SPO-I/PO/Planning Criteria/2015-16/Vol-I, dated 14-09-2015, it is the responsibility of education department to provide classrooms, boundary wall, lavatory block, water supply, electricity/solar system, admin block and play area with all its requirements.

EMIS/IMU data of District Education Officer (Male & Female) Abbottabad revealed that the following facilities were not available in 293 primary and middle schools having 20,849 students.

Non-availability of basic facilities occurred due to weak administrative controls and resulted in poor conditions for the students.

When pointed out in March 2020, the management stated that 70% basic facilities has already been provided to the schools 30% basic facilities was in progress.

Management admitted that basic facilities were not provided in 30% schools.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends provision of basic facilities to students.

# 4.4 Student Enrollment

# 4.4.1 Children out of schools ratio increased from 13% to 22% at primary level.

According to Chapter 5.2 of Education Policy 2009, all children, boys and girls, shall be brought inside school by the year 2015.

Scrutiny of Annual School Census Reports of District Education Officer (Male & Female) Abbottabad revealed that during 2014-15, the ratio of children out of school increased from 13% to 22%

Similarly the student's retention ratio remained at 58% during 5 years.

The increased ratio of out of school children occurred due to weak administrative control and resulted in non-achievement of Education policy, 2009.

When pointed out in March 2020, the management stated that efforts are on cards to bring out of schools children into school through enrolment campaign from the forth coming session.

Reply was not cogent as department did not achieve 2015 target even in 2019 despite the enrollment campaign.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends review of the Education policy 2009.

# 4.4.2 Low enrollment in Government Primary Schools

According to Chapter 5.2 of Education Policy 2009, all children, boys and girls, shall be brought to school by the year 2015.

Scrutiny of Annual School Census Reports of District Education Officer (Male & Female) Abbottabad revealed that during 2014-19, the student enrollment in Government primary schools declined from 92,861 to 74,380 despite the appointment of 700 additional teachers.

On the other hand, student enrollment in private sector had an upward trend i.e., increase in student's enrollment from 58,110 to 72,306.

Audit held that despite a huge investment of Rs14,669.134 million in the education sector the DEO (Male & Female) failed to achieve the required targets.

Low enrollment occurred due to weak administrative control and resulted in student's enrollments to govt. schools.

When pointed out in March 2020, the management stated that enrollment in Government Primary schools is being enhanced through enrollment campaign motivation of parents through incentives like free text books free admissions etc.

Reply was not cogent as no visible impact was shown till finalization of this report and department was lagging behind 2015 target even in 2019.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends that efforts should be made to achieve the targets.

# **4.5** Student Learning Outcomes (SLO)

# 4.5.1 Student learning outcomes below standards

According to five years plan (2018-23) of KP E&SE Department, more than half of the children enrolled in primary schools struggle with basic reading, writing and mathematical concepts. Over the next 5 years, our target is to double the learning levels in primary schools ensuring children get basic literacy and numeracy skills.

According to District Performance Indicators Jan-May 2019, target for average SLO was 52% and according to National education Policy 2009, mean score for student learning outcomes is 50%.

Scrutiny of District Performance scorecard for Jan-May 2019 of DEO (Male and Female) Abbottabad revealed that the management did not achieve their targets as per detail below:

In another assessment for a period between Aug and Dec 2019, it was noticed that only 32.5% male and 33.4% female students of Grade-5 qualified assessment. In other words, 67% students did not qualify the assessment.

Similarly, assessment of Grade-8 results revealed that 60% male and 50% female student did not qualify the assessment.

SLO below standards occurred due to lack of planning and weak performance of education department and resulted in poor provision of quality education.

When pointed out in March 2020, the management stated that the CPD program at Primary level is launched to achieve SLO targets in preceding months.

Reply was not cogent as the department did not achieve SLO target in the light of National education Policy 2009.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends on job trainings to teachers for increasing the SLO.

# 4.5.2 Student learning outcomes target of Grade 10 & 12 not achieved

According to District Performance Scorecard Aug-Dec 2019, target for average SLO was 62% and 61% for Grade 10 &12.

Scrutiny of District Performance scorecard for Jan-May 2019 of DEO (Male and Female) Abbottabad revealed that the management did not achieve their targets as per detail below;

SLO below standards occurred due to weak performance of education department and resulted in poor provision of quality education.

When pointed out in March 2020, the management stated that Teachers at secondary & Higher Secondary level are being trained to achieve SLO target for Grade 10 & 12.

Reply was not satisfactory as no such documentary evidence was provided regarding achievement of SLO targets after teachers training.

Request for convening the DAC meeting was made in September, 2020 with subsequent reminders. However, DAC meeting was not convened till finalization of this report.

Audit recommends on job trainings to teachers for increase the SLO.

# 4.6 OVERALL ASSESSMENT

# Relevance

The office of DEO (male & female) Abbottabad and recruitment of teachers through NTS was in line with government's sectoral policies.

# **Efficacy**

To provide quality education to all, the management started the appointments of teachers through NTS since 2014 but after lapse of almost 5 years the recruitment of teachers was not completed till date of audit thus a number of students suffered badly.

# **Efficiency**

Rationalization policy was also not implemented by the education department whereby 142 teachers were short in GPS/GGPS while on the other hand 190 teachers were surplus in GPS/GGPS. The surplus teachers were required to be adjusted in those schools where teachers were short but the same was not done and 15,590 student's education was affected badly.

# **Economy**

As pointed out in the audit findings, the management could not satisfactorily deliver the quality services to community.

# **Effectiveness**

The number of children out of school increased from 23,006 to 43,127 at primary level, enrollment decrease from 92,861 to 74,380 and student learning outcomes were also not satisfactory as 60% students at primary/middle level and 40% students at high/higher level did not qualify the assessment.

# **Compliance with rules**

Violations of rules have been reported in the audit findings.

# **Performance Rating of Project**

Keeping in view the above situations, the recruitment of teachers through NTS and regularization of them had no positive impact on improvement in service delivery. Hence the performance of DEO (Male & female) Abbottabad was moderately satisfactory.

# **Risk Rating of Project**

Medium

# 5. CONCLUSION

In view of the foregoing audit findings, it may be concluded that the despite the recruitment of almost 700 teachers in various categories, incurrence of huge expenditure of Rs. 14,669.134 million on provision of basic facilities, pay and allowances, furniture etc during the last 5 years (2014-15 to 2018-19), the management failed to make any improvement in service delivery in education sector in District Abbottabad.

# 6. Recommendations

Audit recommends that:

- i. The appointments should be made in the light of ESTA code.
- ii. The rationalization policy should be implemented in true letter and spirit.
- iii. Missing basic facilities in schools should be provided to secure the future of children.
- iv. Efforts should be made to achieve the targets.
- v. SLO should be brought at par with the standard.
