- a. In line with Clause 5.1 of the bidding document, M/S Rehman & Qureshi's Concern Ltd is the "most advantageous bid" after passing through eligibility and qualification criteria is found substantially responsive to the terms and conditions

as set out in the bidding document. There is a substantive difference between service cost with M/S Helou Tech Janitorial Services.

- b. In line with Clause 5.1 of the bidding document, M/s Rehman Qureshi Concern Ltd bid of Rs 57,78,000/- is Rs 90,000/- lower than M/s Helou Tech Janitorial Services (Pvt) Ltd and is ranked the highest rank bid based on cost


