

- a. In line with Clause 5.1 of the bidding document, after observing eligibility and qualification criteria M/s Rehman & Qureshi's Concern (Pvt) Ltd is found most advantageous and substantially responsive on PPRA Format to the terms and conditions as set out in the bidding document. There is a substantive difference between service cost of M/s The Expert Multi Services, M/s M. Maqsood & Co. and M/s Rehman & Qureshi's Concern (Pvt) Ltd.
- b. The lowest bidder, M/s Rehman & Qureshi's Concern (Pvt) Ltd has offered services rate of Rs.8253444/- per annum inclusive all taxes for the subject bid. There is a difference of Rs.965796/- of the second lowest and substantially responsive bidder lower then M/s The Expert Multi Services with the lowest bidder M/s Rehman & Qureshi's Concern (Pvt) Ltd.
